

COMPETITION CONDUCT FORM

Non-profit organizations, USAD® and WIAD, require that each decathlete, the coach(es) and a school administrator sign a Competition Conduct Form prior to beginning the first test. This form is an agreement between the decathletes, the coach(es), a high school administrator, USAD®, and WIAD.

- Each decathlete, coach and a school administrator is to read the statement pertaining to the performance agreement.
- Each decathlete, coach and a school administrator is to sign and date the form on the lines indicated.
- There will be one form per team. Failure of any or all parties to sign and submit form disqualifies Team and/or Decathlete.
- Non-compliance will result in disciplinary action at the discretion of WIAD officials.
- **This form will be returned to the WIAD Office with the essay booklets on December 6 or December 7.**
