Description	<p>This training is another step in the process of resolving conflicts. Peer Mediation is a somewhat formal process in which one impartial person helps others who are in conflict to communicate with each other, to understand one another's point of view, and to reach an agreement that resolves their conflict. In this training, student mediators will learn: communication skills for effective conflict resolution; active listening skills; how to respect different points of view; the role of "feelings" in a conflict; the process of identifying alternatives; how to reach an agreement or settlement or impasse; understanding and empathy of diversity issues in a school setting as it is addressed.</p> <p>*Each team must be accompanied by an advisor. *This training is classified as Universal because all students should have access to Peer Mediator program offerings.</p> <p>Students should have some previous training in conflict resolution prior to attending this workshop.</p>
